



The WatchDec SA company settles in Courgenay

Develier (Jura), 2nd September 2019 - WatchDec, an Acrotec Group company relocates its business to Courgenay (Jura) in a new factory with a total surface area of almost two thousand square metres. Renowned for its know-how and skills in the manufacturing of complex parts for the horology screw machining industry, WatchDec is also active in the production of micro components destined for the connector, medical and aeronautic sectors.

« With this new infrastructure we will benefit from far more space, and therefore be better adapted to the development plan of the company whilst considerably improving the working conditions of our employees» declared Mr Jean-Matthieu Kasprzykowski, General Manager of WatchDec. WatchDec currently employs eighteen employees who will now benefit from better access to their new work location since it is situated close to the motorway, train station and other public transport.

The newly constructed building is equipped with all of the latest technology, in particular in terms of energy. A variety of technical equipment will allow optimal air treatment. Furthermore, the heat emitted from the equipment (machines, compressors...) will be recovered and reinserted into the hot water system. Photovoltaic panels will also produce part of the electricity required and a green vegetal roof will not only provide better insulation for the factory but also collect rain water. This natural infrastructure will particularly avoid overloading the network of rainwater drainage in the commune.

The available space freed up after the relocation of Watchdec will immediately be fully occupied by the Vardeco company, also a member of the Acrotec Group, who keenly need the additional capacity to be able to respond to the development of its business.
